	 Dorset Councillor Carole Jones reported as follows: Dorset Council are developing a Parking Review Strategy which will have 3 levels: Rural, Coastal and Towns. There have been huge problems with the planning process with 8-week delays in validation due to very high volume of applications. Planning Enforcements and Building Control work has also increased. There will be an archaeological dig in Hinton St Mary in the Summer. Council meetings – location of meetings will not be decided until after 21st June when a Government update will be announced. The bin collection changes in days of collection will come into effect in June. Charging points in Station Road carpark will be included in Phase 2 of Dorset Council's charging point scheme.
