<u>Flags and Bunting</u> - The Town Clerk expressed thanks to the Fire Brigade for putting up the bunting in the town for the Coronation weekend.

23/24/015 DORSET COUNCILLOR'S REPORT

Dorset Councillor Carole Jones reported as follows:

- She has received feedback from a recent survey and will circulate the feedback to Councillors.
- The planning application for a hotel and houses at Fiddleford has been refused.
- The Dorset Council Capital Leverage Fund has opened for another round.
- Home Upgrade energy efficient grants (HUG) are available.
- The process for Sturminster Newton High School to become part of the Sherborne Area Schools Trust has been delayed.
- There were household support grants available from Dorset Council, there is so much hardship it closed 30 minutes after opening.
- Cllr Jones had been successful in obtaining a grant for an 8 week course of yoga and Qi Gong. Aimed at improving health and wellbeing the sessions are free and will be held at the Rec.
