Cllrs Donaldson and Mantock had attended a Dorset Council meeting regarding the Local Plan.

The County needs to build a further 25,000 homes by 2043. Consultations on achieving this are being held throughout the County in the coming weeks. Sturminster Newton is not a chosen venue. Cllr Mantock had requested that Sturminster Newton be included.

The Town Clerk has contacted the Neighbourhood Planning team at Dorset Council for clarification about resubmitting the existing plan to ensure the current settlement boundary is revalidated.

COMMUNITY LAND TRUSTS – for discussion on 16th July 2025 at Planning and Environment Committee Cllr Pauline Batstone

Chris Spackman, as Chair of the Sturminster Newton Community Lane Trust has asked for the Council's support with the Trust – in particular he is anxious to recruit more Board Members as he himself is having to stand down. As I understand it, the Council itself cannot run a Community Land Trust but Councillors as independent individuals could be Trustees. So the purpose of bringing this before you today is to ask if any Councillors in their own right would like to be involved, or are they aware of any individuals in the Community who might wish to do so.

Chris's argument in favour of a Community Land Trust is that it can set its own criteria for tenancies, in particular can favour key worker's, and there is no right to buy so the housing stock is secure.

I have asked Paul Derrien of Dorset Council's Housing, whose specialist area this is, to clarify some issues. This is his response -

"Housing Associations are not subject to the right to buy. There was a trial programme that looked at introducing the right to buy for Housing Associations but this was not continued. Some properties are covered by a policy called the Right to Acquire, this depends on how the homes were funded but the discounts are not high and I have never heard of this being used locally. Some Housing Associations do dispose of housing stock, normally older properties. Working in partnership with a CLT would prevent this. It would also safeguard against future legislation changes in regard to the right to buy. If a CLT held the freehold of a property they would need to give approval to any sale.

When homes are owned by CLTs they normally set some local lettings criteria and then allocations are done through the Council. There is normally a local lettings plan and conditions in S106 agreements to ensure to ensure priority goes to local people, or other group the homes are intended for. These will set the rules for allocating properties but the actual property allocation is done by the Council, though sometimes CLTs will verify the local connection. Normally the CLT works in partnership with the Housing Association and they own the homes, the CLT owns the freehold. Having the Council do the allocations ensures a process is followed and we can deal with any complaints, it also means the CLT does not have to deal with the disappointed people who did not get a home.

CLTs can give priority to keyworkers. Dorchester CLT has planning for 15 units that will be allocated to people who work in Dorchester under the age of 35.

Other social landlords can do housing for keyworkers, and we have a couple of schemes aimed at NHS workers. However, we do also have to balance the general need for affordable housing as well as that for keyworkers.

I do think CLTs can be an effective way of delivering homes and for getting local support for new housing projects."
